ASEA MEMBERS VOTE ON OUR LOGO

At our 19th Biennial Convention that took place in March 2024, ASEA members passed Resolution number 4 to make the ASEA logo an official logo as voted by ASEA members. In late June, all Bargaining Unit members should've received an email with an electronic poll (e-poll) allowing them to vote between the logo that was previously used with the blue circle and green Alaska, and the green and yellow logo with mountains in the background. Members voted and selected the green and yellow logo featuring mountains and trees. ASEA is working on converting documents and other materials to reflect this vote.



RESOLUTION ON NOPP GRIEVANCE FINALLY REACHED!

After more than two years, ASEA has reached a resolution for our Class Action NOPP Grievance. This Grievance encompassed 337 NOPPs filed by ASEA members between May 1, 2023, and Aug 30, 2024. Thanks to the incredible work of our Business Agents who refused to give up, the State has agreed to pay respective amounts to settle each of the 337 NOPPs. If you were a part of this Class Action Grievance, you will receive a more detailed communication from ASEA. An important reminder - CHECK YOUR PAYSTUBS EACH PAY PERIOD and report any discrepancies IMMEDIATELY. Notify ASEA at the same time so we can help ensure resolution is met (no matter how long it takes!)
